Level 1 ACI DEALING CERTIFICATE course



The **ACI Dealing Certificate** is a foundation programme that allows candidates to acquire a working knowledge of the structure and operation of the major foreign exchange and money markets, including the ability to apply the fundamental mathematics used in these markets, and their core products (cash, forwards and derivatives), and the basic skills required for competent participation in these markets. Candidates should also be able to apply The Model Code to their own and market situations.

- Middle office and operations personnel;
- Auditors and compliance officers
- Treasury Sales and marketing staff;

Level 1 ACI OPERATIONS CERTIFICATE course



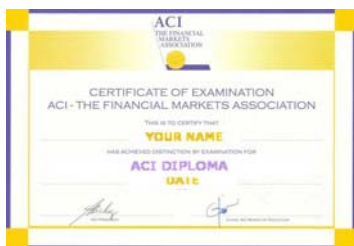
A well-trained and efficiently organised Treasury Operations Department is essential to complete every transaction. The Operations Department provides a vital service to the Front-Office by ensuring that all funds flow in a timely and correct manner and that all the necessary documentation is completed. Taking into consideration the wider job function of the Operations Staff, the **ACI Operations Certificate** examination has been designed to provide a benchmark for competency in all aspects of the operations and settlement processes. It aims

to test candidates' knowledge of the underlying instruments involved in the international financial markets, the processes for efficient settlements and related basic financial calculations. Candidates should also be able to demonstrate appreciation of the scope, importance and the role of Operations, particularly in ensuring an autonomous service to the Front-Office.

Level 2 ACI DIPLOMA course



As continuing professional development, the **ACI Diploma** builds on the Dealing Certificate and Operations Certificate to ensure candidates have a good practical knowledge of the treasury and foreign exchange markets as a whole and of the linkages that exist between the different areas. In achieving this qualification, candidates will have obtained a fundamental knowledge of the mathematics and pricing relationships of the various instruments.

Note: In order to be eligible to sit the ACI Diploma examination, candidates must have achieved a Pass in the ACI Dealing Certificate or ACI Operations Certificate examination.

WHAT IS ACI?

ACI - The Financial Markets Association (www.aciforex.org) is a leading, global association of wholesale financial market professionals with some 13,000 international members in 68 countries. There are 64 national associations which are affiliated to ACI International. Supported by its huge network of market experts ACI contributes to market development through education and certification, setting benchmarks for market practices (The Model Code) and offering technical advice through various working groups such as the ACI Foreign Exchange Committee and the three ACI Euribor committees; Money Market and Liquidity, Derivatives and through communication with the European Commission. ACI represents the interests of its members working within financial institutions or financial services providers. Its members are primarily engaged in financial trading or in sales within the global financial markets.

ACI QUALIFICATIONS

In the area of education and certification ACI offers three examinations, the **ACI Dealing Certificate**, the **ACI Operations Certificate** and the **ACI Diploma**. The ACI education programme represents the highest standards of professionalism and market expertise in the global financial markets. The ACI Board of Education has decided that ACI Dealing Certificate holders will automatically be awarded the title **ACI DC**, ACI Operations Certificate holders **ACI OC** and ACI Diploma holders **ACI Dipl.** which may be put on their business cards. The titles reveal that the candidate has been successful and has become a part of the ACI community of excellence.

The FSA in the United Kingdom has now registered the **ACI Dealing Certificate** and the **ACI Diploma** for “Dealing with Securities and Derivatives” as well as for “Advising on Securities and Derivates”. The ACI exams are now listed on the FSA’s “List of appropriate Qualifications” which is published in the FSA Policy Statement on Competence & Ethics. As a result, these ACI qualifications have become part of the FSA’s training & competence regime for the financial industry in the UK which is clear evidence of the high quality and relevance of the ACI education programme. The FSA only applies to UK-regulated financial entities, yet because of the importance of the UK financial markets, the FSA decision is considered to be of major importance for financial markets participants and regulators world-wide.
